- TREASURER'S REPORT as of February 28, 2019 (monthly report attached)
  - o Scholarship fund business savings account ending balance as 2/28/19 = \$1,809.23
  - Money market account -ending balance as of 2/28/19 = \$16,509.69
  - Business checking operating account ending balance as of 2/28/19 = \$765.24

- TOWN AFFAIRS
  - o On Monday March 4<sup>th</sup> at 7:30 pm there is a Public Hearing at Clay Town Hall for the consideration for the application to allow the sales and rental of motor vehicles by The Great Outdoors Recreation Center Inc at the former Toys-R-Us site at 4155 State Route 31.
  - o The Town of Clay is looking for residents' comments and input for the use of funds by the Town filed with the Onondaga County Community Development for 2019. The hearing is scheduled for Monday March 18<sup>th</sup> at 7:30 pm at the Town Hall on Rt 31. Discussion on funds: all agreed to see if it's possible to expedite paving for entire community; right now slated for 2022. Mike and Kristine to work to put together an online petition for this and ask community to submit pictures for proof of case. Kristine will post on all communications platforms.

  - o The budget for the 2019-2020 school year will be adopted by the Board of Education on April 8. The vote for district residents to approve the budget and elect Board candidates is May 21. There is a video on the district website that explains the budget process.
  - o The new owners of the Great Northern Mall challenged the mall assessment, as the last selling price was considerably lower than the current assessment. The school district settled with the mall owners for a reduction of assessed value, with decreasing values over a three year period.
