**Treasurer's Report by Kyle Adams:**

- Payment for new signs will reflect in April. Few hundred revenue, Flamingo Bowl and Michael C. Graham paid \$200 each for sponsorships. \$100 dues, some scholarship donations. Small pay outs for printer paper and toner.

**Town Affairs by Jordan Curtis:**

- April 7, 21 Town Board meetings, 7:30pm. April 9, 23 Planning Board meetings, 7:30pm. April 12, Bunny Trail, 10am-12pm, Clay Town Hall (4401 Route 31). April 14, Zoning Board of Appeals meeting, 6pm. April 18, Town of Clay Offices close at noon for Good Friday; Highway Department close at 11am.

**School Affairs by Mary Eidt:**

- Capitol project (additional funds) revote passed, 472-193, no increase in taxes. 2025-2026 school calendar set. Friday May 23 no school due to unused snow day. Budget vote May 20, 6am to 9pm. Public hearing May 8. School board candidates and Liverpool Public Library budget also to be voted. Spring recess April 14 to 18.

**Website updates:**
